Update on the Lynnhaven Dredging Project Monday, March 13, 2006

Langenfelder Marine has begun to mobilize, but the dredge will not be here until late this week or next week. This will be a much larger dredge than has been out there recently and is being brought in to complete the entrance channel dredging. They will be installing a larger pipe down the beach for the larger dredge and will begin pumping at approximately station 38+00 (about 2 blocks west of the Powatan/Jefferson Blvd intersection) and proceeding westward. Once pumping begins it is estimated that there is about 70,000 cy of material to dredged and should take approximately 3 weeks to complete, weather permitting.

Woodside, currently working in the turning basin, will continue working but may drop back and fill in some of the areas where the material has washed away.

Highlight of Minutes from 03/09/06

Shortly after 7 p.m. it was determined that a quorum (20 members) was not present to conduct business and President Ronda Morrison noted that the minutes from the prior meeting could not be approved, but asked if everyone had read them. The next item she brought to everyone's attention was the recent installation of "poop boxes". She noticed that many more residents are cleaning up after their pets, but asked that people monitor the boxes and refill them with plastic bags as often as possible. She suggested that residents "adopt" a box and be responsible for seeing that it is filled.

There was then a discussion on the opening of Deep Blue Marine on Shore Drive. It was explained that this company had been granted a concession in order to move their equipment in, but cannot open for business until other requirements are met.

Ms. Kane then went over the Treasurer's Report as of February 28, 2006. She reported the balances in the savings and checking accounts at BB&T as follows: Savings: \$8542.00, Checking: \$2152.42. She also reported that a thank you note had been received from the Ocean Park Rescue Squad for the donation made to them by OPCL.

Ms. Morrison stated that the Zoning Committee Chairperson had stepped down and called for the members of that committee to set a date to meet. Ms. Kane stressed the important role the committee can have in bringing the voice of the residents to the City Council and Ms. Morrison gave as an example the current development under contract on North Oliver. Currently, there exist nine homes on this small street, with 80 new units being planned. The estimated impact on traffic would go from 90 to more than 500 cars in the same time period. It was noted that in prior instances, numerous variances to zoning laws had been granted, with unsatisfactory results, simply because the community did not stay on top of the situation. A tentative meeting date was set for March 22nd at 7 pm at the Ocean Park Fire and Rescue Station.

Carl Godwin brought up a case currently before the Wetlands Board, requesting variances to actually build on top of dunes. He has a feeling the variance would pass and asked that people attend a meeting at Council Chambers on March 20th to voice their concerns. Car-pooling was encouraged.

Judy Connors spoke about the upcoming City Council election on May 2, 2006. She said there are ten people running for office, along with Ron Villanueva, the only incumbent. She strongly advised the formation of candidate's forum to advise the candidates of our positions. Ms. Connors also mentioned an event called "Breakfast with Barbara", being held on April 1, 2006 at the Virginia Beach Resort and Conference Center. Barbara Henley has arranged the breakfast to hear the community's concerns

Ms. Morrison brought up the issue of bi-monthly meetings, but pointed out no vote could be taken, since quorum had not been attained at the meeting.

Jill Broome then asked if there had been any further plans made for the Community Yard Sale. Ms. Morrison said there had not, since no one had volunteered to chair the committee. Liz Dyer was asked if she would chair the committee and she agreed to do so. She did state that she would only be available after school ends in June.

Anne Kane gave an update on the Shore Drive Beautification Project. Work has been approved to start in the spring and will extend from First Court Road to Marlin Bay Drive and will include bike paths and walkways.

Minute Highlights from 4/6/06 Board Meeting

The primary discussion concerned the status of the OPCL appeal to the Virginia Marine Resources Commission (VMRC) of the Virginia Beach Wetlands Board decision to grant a construction permit on 3796 Jefferson Blvd., Virginia Beach, VA. Judy Connors opened by questioning why another application for construction on Jefferson Blvd. which was approved by the Wetlands Board on the same day was not also under appeal. The reason given was that only the proposal for 3796 Jefferson appeared to encroach on a primary dune. John Wigmore noted that OPCL had previously stated that it would oppose any request for variance in Ocean Park. However, Kane and others amended that it was not that OPCL would **oppose** any variance, only that OPCL would not **support** any variance. Additionally, OPCL did not oppose development, only that the League wanted to see **responsible** development. It was further noted that this matter was not a request for variance, which is an application to the Board of Zoning Appeals.

Diane Muhlendorf, Zoning Committee Chairperson, who attended the Wetlands hearing, did not believe that what was projected at the hearing was an official site plan. She had been in contact with Mr. Wayne Couch, a city employee about getting a copy of the site plan. Muhlendorf then read the acknowledgement sent by VMRC to Mr. David Hay, a land use attorney retained by OPCL to represent OPCL at the VMRC appeal hearing. She then expressed difficulty in acquiring a transcript of the Wetlands Board hearing, which VMRC stated would form the basis of the appeal process.

Someone asked if any contact had been made with the owner, Clint Bradshaw, or his attorney Eddie Bourdon to discuss a possible compromise. Muhlendorf said that Scott Ayers, who had some experience in these matters, was not optimistic about any compromise in this case. Wills volunteered that he had spoken briefly with Bourdon, who while not totally uncooperative, asked questions Wills was not able to answer, not having an official OPCL position to offer. It was then posited that Hay attempt to find common ground with Bradshaw, but Wills noted that OPCL might be better served to work out some agreement on a more direct basis.

Prior to the meeting, both Kane and Wills had been in contact with State Delegate Leo Wardrup to see if the proposed construction violated any aspects of legislation he had sponsored protecting the dunes. Muhlendorf stated that Ayers had told her that Wardrup's legislation was too vaguely worded to be very effectively applied but he could be influential. Connors volunteered to contact Wardrup to find out more about how his legislation might serve the cause.

In other Zoning Committee business, Muhlendorf related her inquiries regarding demolition at 3768 Surry Road and she called the city and was told that no demolition permit or construction permits had been issued to that address. She was assured that an inspector would be sent to the site. When she called back a couple of days later, another city employee in the Building and Permits office told her that a permit for demolition had been granted on April 9, 2006. As yet, no construction permit has been granted, according to the city employee.

In closing discussion, Muhlendorf said that she had been told that the only hope OPCL had on the VMRC appeal was for Hay to prove that the Wetlands Board had acted frivolously, but that Hay was prepared to go forward on all six objections listed in the petition signed by 74 residents and filed on OPCL's behalf. Connors asked if anyone knew how to discover what guidelines the Wetlands Board operated under and Kane responded that the city Website provided only a very vague mission statement. Someone then asked if this matter infringed the Chesapeake Bay Preservation Act and should be heard by the Chesapeake Bay Preservation Board, but no one could supply any information about that body.

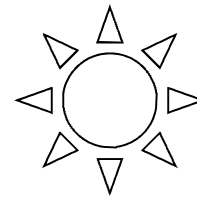

Ocean Park Zoning Committee Looks to Our Future Diane Muhlendorf

And what we see is not necessarily a pretty picture. The Zoning Committee of the Civic League wants to participate in plans for future development of our neighborhood. We want developers and property owners to work with us and yes, to seek our approval of their plans. We certainly are pro-development, but in a responsible manner which protects both the environment and the rights of property owners. For a very long time building permits, variances, and assaults to the wetlands and beaches have been granted without very much successful opposition from Ocean Park residents. If we are interested in having input and impact on our future growth, each of us needs to voice our concerns and actively participate in achieving our goals as each issue arises. Of course goals may be different for each property owner, but a consensus can be arrived at which satisfies the majority of the needs of each of us as well as the requirements to maintain and enhance the very special beauty of Ocean Park.

The Zoning Committee has been granted an appeal to the Marine Resources Commission to protest the granting of a building permit on Jefferson Boulevard which would encroach on and alter the primary sand dune. Our Counsel is David Hay who has extensive experience in arguing to protect the dunes. The meeting is on Tuesday, April 25th. The permit was granted by the Wetlands Board in spite of the fact that the Planning Commission staff argued for deferral pending a review of alternative solutions. It is our hope that winning this appeal will send a message to builders that we care about how Ocean Park will develop and intend to play an active role in that development.

We are also beginning to be mindful of requirements for permits and signs which will tell us when changes are about to be made in land use. Each of us can be helpful by notifying the Zoning Committee of these potential changes as we walk or ride around the neighborhood. We will then check with the appropriate permit department to see to it that all necessary forms have been filed and that signs are put up in a timely manner.

Please let us know if you would like to participate on the Zoning Committee. We need your help and we want your opinions!! It would be ideal if we can have a committee which represents a broad range of ideas.

Lynnhaven River System Implementation Plan Meeting Notice

The Virginia Department of Environmental Quality has classified the Lynnhaven River System (Lynnhaven Bay, Broad Bay and Linkhorn Bay) as impaired due to violations of the state's water quality standard for fecal coliform bacteria in shellfish waters. A TMDL report, which establishes loading limits for these waters, has been completed by DEQ and approved by both the State Water Control Board and the U.S. Environmental Protection Agency. The report is available for review on the DEQ website at <http://www.deq.virginia.gov/tmdl/implans/drafts/lynnhvnp.pdf>.

The Hampton Roads Planning District Commission is working in cooperation with the City of Virginia Beach, DEQ and the Virginia Department of Conservation and Recreation to develop an Implementation Plan to begin achievement of the Total Maximum Daily Load (TMDL) established for fecal coliform bacteria in the Lynnhaven River System.

The Virginia Department of Environmental Quality will be holding a meeting on the draft plan on **May 4, 2006, at 7 PM at the Princess Ann High School** on Virginia Beach Blvd. They will be taking comments on the plan for the thirty days following the meeting. Be sure to come to the meeting and get informed

Since the first public meeting on March 10, 2005 (minimal outreach caused only a few folks to show up, so don't miss this one), federal, state, and local government officials have been meeting to formulate a plan to reduce fecal bacterial levels in the watershed. This draft presents some options - but they aren't cheap - \$10.6 million up front and \$6.8 million a year to maintain.

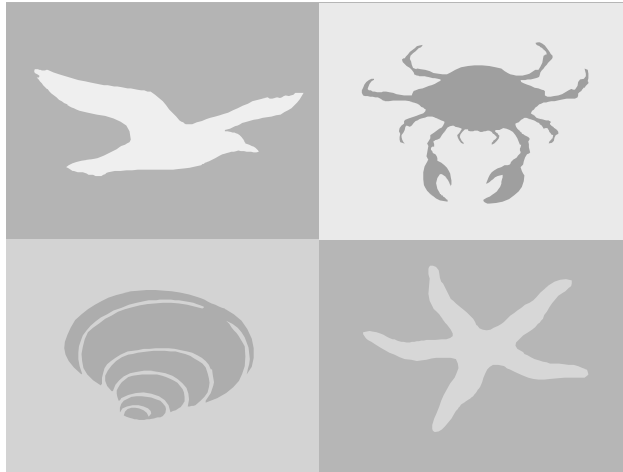
