# Fireworks Update!

Expect a much larger and more spectacular show this year. The explosive shells in the past measured two

inches in diameter and went up about 200 to 250 feet in the air. This year, because the barge allows the permitted distance from people, we upgraded to eight-inch shells, which can reach heights of 600 to 900 feet. Not only will the entire crescent of beach from Little Creek to Lesner Bridge have an excellent view, but the Eastern Shore

and Pembroke will see them.

In January the beach measured too thin to allow even the show from last year to repeat. With the anticipation of more beach loss before July, and because the permit deadlines didn't allow a change the location once we applied in March, we had to look at an option. If we lost too much beach, we wouldn't have a show or the down payment. The safer bet became the barge show. Safer in monetary risk and in liability. The barge will sit roughly 900 feet off the beach in front of Aries

(chosen for the water depth, the central location, etc.) We significantly reduced the chance of an explosive accident during the show and during the loading process.

Due to the higher cost of the barge show, the three bayfront civic leagues will raise money for the show together.

As part of that joint effort, all civic leagues will promote and support any fireworks fundraising efforts. Please help us work together to have the best little show in Virginia Beach.



# Pleasure House Point Stakeholder Committee Meeting

The Pleasure House Point Stakeholder Committee held its inaugural meeting at the Bayside Recreation Center April 23, 2012, co-hosted by the city of Virginia Beach and the Chesapeake Bay Foundation (CBF). The almost 100 percent

attendance by appointed representatives showed a remarkable demonstration of interest and commitment by the city and the public.

Brian Solis, of the city's Open Space Committee, opened the meeting and provided the following information, available soon on a city and CBF websites. CBF spokespersons also supplied information about their vision for their facility, which would have the three-fold function of environmental center, environmental education center and environmental restoration site. They hope for the building to go beyond LEED certification to "Living Building" designation. See https://ilbi.org/ for more information.

The outline describes the project as "a natural conservation area, public park and environmental education area. Partners are the city, The

Trust for Public Land (TPL) and CBF. Funding partners are U.S. Fish and Wildlife Service, Virginia Department of Environmental Quality, Virginia Department of Conservation and Recreation, Virginia Beach, the Trust for Public Land, CBF, Dominion Foundation, Virginia Beach Parks and Recreation Foundation and the citizens of the Shore Drive

area. The city seeks public input prior to formulating the plans for this area.

The project timeline lists planning in May 2012, rezoning, permitting, acquisition by CBF of their 10-acre parcel on or about January 2013, and design and construction of the city portion January 2013 through December 2013.

The presentation offered a brief history of the property and

included maps of the parceled areas, showing storm water management and proposed soft trails, kayak launch area, and a sidewalk with adjacent parallel parking along the northern portion of Marlin Bay Drive

Miscellaneous enclosures included a section for habitat preservation and the threatened and endangered species that call PHP home, as well as the results of a survey conducted earlier from at least two meetings available to Ocean Park Civic League residents.

The city proposes three or four more of these meetings in addition to a yet-to-be-scheduled public meeting. The meetings are, of course, open to the public, but in the interest of time, observers are asked to channel their input to

RESPONSES TO QUESTIONS
CONCERNING THE PROPOSED
INDUSTRIAL FACILITY
AT THE LYNNHAVEN BOAT
RAMP AND BEACH FACILITY
(LBR&BF) POSED BY THE OPCL
-WATERWAYS DEVELOPMENT
COMMITTEEE

1. What is the process of creating and implementing the DMTS proposed plan? Briefly describe, from start to finish, including who initiated the DMTS proposal and the steps through city departments and any other agencies needed, the approvals required, including the acquisition of permits and award of contracts.

#### Response:

The Lynnhaven River was reasonably divided into five control areas. Within each control area, the staff selected at least one site which will be able to serve as a public transfer site. Essential to that site selection is its proximity to main transportation routes and a minimal impact to residential areas. The purpose for creating public transfer sites is because many of our residential streets cannot support the load bearing weights of multiple trucks which would result in the destruction of our neighborhood streets. Additionally, these transfer sites will be used for supporting the transfer of material in support of maintaining Coast Guard approved navigation channels whose responsibility for periodic maintenance resides with the city of Virginia Beach.

2 The Virginia Beach application for the dredging of the Western Branch of the Lynnhaven, page 3, notes that spoils will be transported to Thalia Creek. Does that mean that the dredge spoils from the main channels from the Lesner Bridge to Thalia can be handled by the Thalia site? *Response:* 

No, not without an exception being granted to the control area concept. The Thalia site distance from the Lesner Bridge creates an extraordinary financial burden to the contract costs and is located in a different control area.

3. Who is or was responsible for identifying the potential sites for DMTS locations in 2008 and now?

#### Response:

The City Water Resources Staff, overseen by the Department of Public Works and Deputy City Manager Dave Hansen, comprise the Neighborhood Dredging SSD Project Delivery Team who undertook the task of identifying potential sites for transfer operations.

4. What other potential sites have been identified and what criteria have been used to evaluate them, especially sites in benefitting neighborhoods? *Response:* 

In addition to the Thalia site and the Crab Creek Dredge Material Holding site, we are looking at the Pep Boys site to support the dredging program.

5. How can we be assured that the city has conducted a thorough evaluation of alternative sites when you previously failed to identify the Thalia site and Boatel site?

#### Response:

Staff has spent a considerable amount of time assessing all waterfront properties and has a thorough knowledge of the neighborhood road system as well as the boat ramp accesses within the Lynnhaven watershed.

6. With the citizen-identified "Lynnhaven Boatel" site now city approved, why is it necessary to have another spoils site located less than 1.25 miles away?

#### Response:

At this point we are not pursuing the Boatel site. With City Council's recent Resolution, we will not pursue the Maple Street to support Neighborhood Dredging SSD projects. Whether the Boatel site is finally developed is a future question, but it is nonetheless located within another control area and does not serve the interest of the northern portion of the western branch channel, nor does it serve the interests associated with the inlet itself.

7. A posting on the Virginia Beach city website from 2009 states: "Based upon feedback received at the Public Meeting, alternate sites for a dredged material transfer station were evaluated. The proposed transfer facility

has been moved from the Lynnhaven Boat Ramp Facility to a site located near the crossing of Thalia Creek and Virginia Beach Blvd." Why has the LBR site been added back to the plan?

Response:



Once again, the location of the Thalia transfer site is not felt to be fiscally affordable to support the northern reach of the western branch or the Lynnhaven Inlet itself. The Beaches and Waterways statement that the Thalia site was the Lynnhaven Boat Ramp site being moved is incorrect and without fact.

8. The report prepared by the Beaches & Waterways Advisory Commission in January 2012 states that the decision against using Maple Street was due to the negative impacts on the neighborhood, property values, and quality of life. Why do you believe that those negative impacts would be acceptable in our neighborhood? Particularly, since we will not benefit from this program in any way.

#### Response:

Use of the LBR for transfer operations will minimally impact the Ocean Park neighborhood, not reduce property values, and will not reduce the quality of life for the neighborhood which already entertains significant public access traffic for using the public boat launch amenity and beach access parking.

9. Why does the city think it's appropriate for Ocean Park to bear the acknowledged impacts of a DMTS for the benefit of waterfront property Owners' miles away?

#### Response:

Because the Lynnhaven Boat Ramp is a

public site as is the Crab Creek Dredge Material holding site. Creating an ability to support multiple tasks makes it an ideal location without incurring additional costs to our city's taxpayers.

10. Ocean Park residents and homeowners are major stakeholders in the Crab Creek recreation area and propose DMTS site. How will the city keep an open dialogue on this with the Ocean Park Civic League in the future?

#### Response:

Just as we have recently done, through our briefings to the Bayfront Advisory Committee and our staff's attendance at your Ocean Park Civic League meeting, we will remain available to continue the dialogue and have committed to a midproject review of our performance in operating a construction equipment material and lay down yard in support of the that includes the loss of tax base as Lesner Bridge Replacement Project.

11. The 150,000+ citizens who use the Lynnhaven Boat Ramp and Beach Facility are also major stakeholders in Response: the DMTS proposal. What is the city plan to create and maintain an open dialogue with them?

#### Response:

The city will go to great lengths to ensure that LBR is available throughout the construction period of the Lesner Bridge replacement and would create the operational procedures necessary for coexisting while any transfer operations for future missions were underway. Adequate public notices will be key to keeping our citizens and visitors informed.

12. Have you asked the VMRC for their position on turning a state funded boat ramp into an industrial site? (If not, why not? Or What was their response?)

#### Response:

We do not intend to turn the state funded boat ramp into an industrial site. It will remain a boat ramp facility. Adjacent to it will be the creation of a transfer site with appropriate accesses utilizing the boat launch site.

13. Given the proposed investment and plans of the Chesapeake Bay Foundation for Pleasure House Point, have you contacted them for feedback on the proposed DMTS at LBR? (If so, please share.)

#### Response:

We have notified the Chesapeake Bay Foundation of our intentions for constructing a transfer site at the Crab Creek dredge material holding area and have not received negative feedback.

14. The Beaches and Waterways report recognizes the concern for decreased property values if a DMTS were to be located at the Lynnhaven Boat Ramp. How will property owners be compensated for the loss of value and/or the increased difficulty in selling?

#### Response:

We do not believe that the property owners will suffer any loss of value and/ or any increased difficulty in selling by the location of a transfer facility at the Crab Creek dredge material holding site. 15. Has an economic study been done property values decrease and the loss of revenue as boaters and fishermen go elsewhere?

We do not believe that property values will decrease as a result of the creation of a transfer site at a location the currently provides for the retention of dredged material. Furthermore, we do not believe that revenue will be lost from LBR because we intend to co-exist.

16. The report states that "the Crab Creek DMTS be restricted from operation for anytime greater than one work segment not to exceed 60 consecutive workable days during any three year cycle." Does that mean 60 days in three years or 60 days per year for three years?

#### Response:

Staff does not agree with the Beaches and Waterways Committee that the Crab Creek DMTS should not be used in excess of 60 workable days in any three year cycle, nor has Council endorsed that recommendation.

17. On page 4 of the report it states that the program will operate at Crab Creek from Memorial Day to Labor Day (summer) while page 21 states that it will operate from Labor Day through Memorial Day (winter). Which one is correct?

#### Response:

Operational periods at the Crab Creek

transfer site will be determined through the permitting process and with the approval of City Council. We prefer not to restrict time of use periods because, in any case, the Lynnhaven Boat Ramp will be fully functional at all times.

18. It also states that it may operate during the summer with "special relief." What specifically is "special relief?" What will be the criteria for granting such relief?

#### Response:

We do not know what the Beaches and Waterway Committee is referring to by "special relief." Therefore, no criteria have been established. Please refer to the answer to 17 regarding approvals for use of the transfer site.

19. Why can't private property owners in private neighborhoods continue to develop and implement their own private dredging plans as previously done?

#### Response:

Staff's first preference for locating a dredged material transfer site will be to limit it to that neighborhood in which that neighborhood dredging project is being conducted. As referenced in an earlier answer, many of our city's roads were not constructed such that large truck traffic can be sustained. In such cases, the destruction of public roads is unacceptable. Establishing publically accessible logistics nodes with limited impact is key to the systems approach necessary for implementing the Neighborhood Dredging SSD Program.

20. Is dredging of privately owned neighborhood canals considered a "core" city service?

#### Response:

The Neighborhood Dredging SSD Program is a key initiative in support of the City Council's fourth strategic goal: Revitalize the city's neighborhoods and plan for the future. The cost sharing partnership establishes an acceptable fiscal arrangement whereby our taxpayers have an opportunity to reclaim the value of their properties while having a positive overall effect throughout their neighborhood. The definition of "core" can be construed many ways; but, the maintenance of navigable waterways could be deemed core.

Ocean Park Waterway Development and Redevelopment Committee OPWDRC

Due to the large number of federal, state and municipal development and redevelopment projects scheduled to begin in the near future within Ocean Park, this committee formed to streamline questions and answers to and from the appropriate regulatory agencies dealing with these projects. OPCL President Martin Thomas appointed the OPWDRC at the March OPCL meeting and it has met three times since that appointment.

The last informal meeting took place at the Jordan Bridge replacement project April 21. The Jordan bridge, also a replacement bridge, has the same builders who designed the replacement Lesner bridge. The OPWDRC reports that a bridge replacement pre-

sents a very disruptive and complex project.

Other issues within the scope of this committee include the proposed dredge spoils transfer station, development at Pleasure House Point, Osprey Point Park and the Lesner bridge replacement. The OPWDRC reports to Ocean Park Civic League at each general membership meeting. The city of Virginia Beach answered a significant list of questions regarding the

dredge spoils transfer station. See the initial letter and the city response on pages 6 to 7 of this newsletter or on the OPCL website.

When I jumped headfirst into the Ocean Park Civic League I quickly learned that the committees and the city representatives use many acronyms to shorten the names of locations, groups, divisions, etc. It can be very confusing to a newcomer or to those not regularly involved in meetings. To help shed light on some of this, I will include an explanation for frequently seen acronyms. In all newsletter use I will always follow Associated Press Style and identify by full name on first reference and acronym thereafter in each

#### The SDCC Meeting Wrap Up

The Shore Drive Community Coalition met February 27, 2012. The following notes came from the meeting minutes.

Dave Williams gave a brief overview of the Virginia Beach Beaches and Waterways Advisory Commission (B&WAC) meetings he and several other concerned citizens attended and stated that they provided little opportunity for an open discussion of the major issues. The committee does not allow public comments and questions at meetings.

Vice Mayor Louis Jones submitted a resolution to remove the Maple Street site from the Neighborhood Dredge Spoils

Program. City council unanimously voted to remove the site.

Williams pointed out that although the city had instructed the B&WAC to study the impacts of dredge site use and conduct a formal public input meeting, no neighborhood impact studies (safety, environmental, real estate, damage to the infrastructure, private use by non-SSD participants, insufficient cost planned and estimates, and the technical issues involved with mechanical dredging compared with hydraulic dredging) have taken place.

# Species diversity in Virginia Beach waters

The Chesapeake Bay, located in a biogeographic boundary, represents the furthest south that many cooler water Northern species are found, and the furthest north that many warmer water Southern species are found. Over 250 different species of fish have been found in the Chesapeake Bay. Many of the fish found in the Bay, such as lined seahorse, surprise people. A host of resident fish live here all year long, and

even more transient species visit in the winter or summer.

Northern visitors include scup and cunner. The books report winter flounder come into the Bay, but I've never seen one. Friends of mine have come across seals resting themselves on our Bay beaches during winter walks. These Northern visitors also haul out on the rocky Chesapeake Bay Bridge Tunnel islands and ocean beaches from time to time. Northern gannets can also be found diving for fish in the lower Bay,



especially during the late winter and early spring when schools of baitfish return.

I get to see hundreds of seine nets pulled in from our local waters during the summer, so I'm more familiar with our tropical Bay anchovy visitors from the south. Crab scrapers occasionally

find species of butterflyfish in the eelgrass beds in Tangier Sound and fishermen catch grey triggerfish half way up the York River. Pink, white and brown shrimp of edible size can be found in the Lynnhaven River and farther up the Bay, especially during dry summers. Other visitors from Southern waters include Florida pompano, gray snapper, mojarra, pinfish, pigfish, halfbeaks, houndfish, Southern stargazers, juvenile Crevalle jack, banded rudderfish and a whole lot

more.

The Virginia Institute of Marine Science (www.VIMS.edu) captured the following species with a 100-foot seine net in unvegetated sandy bottom sites in the lower Bay (Austin et. al 1996). There are many more visiting species to be found in the estuarine waters around Virginia Beach if you know where to look and how to catch them.

#### What in Ocean Park is that?

The wood roach
does not live inside
structures. It
merely visits. Also,
if it makes you feel
better call it a
"Palmetto Bug"
but it is not a
"Water Bug"
Water Bugs are
truly aquatic bugs
and something
different.

Often confused with it's cousin, the American roach, the Wood roach (or Pennsylvania wood roach) prefers to eat outdoor decaying organic matter. Females deposit their egg capsules outdoors under old logs, stumps and firewood. There is one generation of wood cockroaches per year and, in

some cases, the life cycle takes two years.

**Wood Roach** 

Attracted by light, unlike all other cockroaches, they often fly to outdoor lights at night, especially during May and June. They may enter homes via cracks through which light is visible at night. At dusk, males may take short flights and are drawn to porch or house lights. They also come in through doors as they open or on items brought in from outside. An inspection of your home after dark may show visible light through cracks or openings.

Seal up possible entry points using an easy-to-use product called Xcluder. It is much like steel wool, but it doesn't rust. Make sure doors and windows have tight-fitting screens and exterior vents and louvers are covered with screen. Most actual infestations involve colonization outdoors of the spaces underneath wood shingles or siding. To control wood roaches in such spots, use a bulb or power

duster to puff less toxic insecticide dust, such as boric acid or diatomaceaous earth, into space under the shakes. Be certain to wear a dust mask during application and to follow label directions.



Wood roaches do not survive indoors which is probably the best news you have read so far. They require the consistently moist environment of their natural habitats such as under wood piles or loose bark and in decaying logs. So, unless your house-keeping is way below par, the presence of wood roaches is strictly a temporary annoyance. They usually die within a few days in the house, so a call to the exterminator is usually not required.

If Wood cockroaches are found anywhere inside the home, usually they are solitary. So, it's not necessary to go looking for the mate. Wood cockroaches do not reproduce or multiply inside. Since wood cockroaches do not establish themselves indoors and their presence is temporary (a few weeks, at most) during the spring, chemical pest control measures indoors are rarely needed.

If you live in Ocean Park you can find them. At night, crawling up a neighbor's siding, scrambling in the road near the manholes, under the live oak leaves and in fireplace wood.

Wood roaches are not German cockroaches. German cockroaches infest restaurants and homes. Exterminators find German cockroaches difficult to eliminate since they live, eat and reproduce indoors.

In addition to the listed methods of combat, I will add something found completely by accident. Spraying them with Lysol Antibacterial Kitchen Cleaner stops them in their tracks. Literally. I don't know what that says about the substance meant to clean your counters.




