New Membership Cards will provide discounts at local businesses

Your OPCL membership committee has been working on new programs to increase membership and give our members added benefits for belonging to OPCL. Since I took the position of membership committee chairman last year, I've had many folks ask me "why should I join?" Beyond helping your local community maintain its unique neighborhood and being able to vote at meetings, I had nothing. So the membership committee has decided to add an incentive to join. Coming soon, all current paid members will receive a membership card, which will give you discounts at local businesses. The discounts will more than pay the cost of your annual \$15 OCPL dues. At press time, we did not have the final list of businesses, but we expect to have it soon. We will run the names of the participating businesses in the Echo, and on the back of the membership card.

I have received feedback from members who were unsure if their membership was current. We are implementing two things to resolve this. On March 24, 2009, the Virginia Marine Resource Commission (VMRC) approved two permits for a total of three pound nets off the Ocean Park/Baylake beach area. The board's decision was based on the location of the nets being 1,500 feet from shore and the required use of a modified leader that may help reduce dolphin kills.

In addition to sending a letter in opposition, I attended the hearing in person and spoke out against these nets as a matter of public interest and safety. I pointed out the fact that this area is utilized by thousands of recreationalists on boats, jet skis, kayaks, Hobie cats, windsurfers, etc. and thus would pose a navigation and safety hazard. VMRC also received over 40 additional emails in opposition and seven in support.

The board was not swayed by the possible safety and recreational impact to the community or the possibility of dolphin entanglements. In the end, the rights of the two fishermen overruled those of the entire community.

OPCL's board felt that this decision was arbitrary and in direct violation of VA Code which states:

WHAT IS A POUND NET?



A pound net is a visable passive (stationary) gear type used for the live-entrapment of fish species.

This gear is constructed using an arangement of fiber netting supported upon a series of stakes or pilings.

A pound net consists of three main sections:


- 1. A crib/pound (A) which is the enclosed end where the entrapment takes place.
- 2. A heart (B) which is actually a net in the shape of a heart that aids in funneling fish into the crib.
- 3. A hedging/leader (C) which is a long straight net that leads the fish off shore towards the crib.

Fish swimming along shore are turned towards the crib by the hedging, guided into the heart, and then into the crib where they are removed periodically using various techniques.

"...the Commission shall also consider the public and private benefits of the proposed project and shall exercise its authority under this section consistent with the public trust doctrine as defined by the common law of the Commonwealth adopted pursuant to § 1-200 in order to protect and safeguard the public right to the use and enjoyment of the subagueous lands of the Commonwealth held in trust by it for the benefit of the people as conferred by the public trust doctrine and the Constitution of Virginia."

The Board decided that the decision should be appealed to the Circuit Court and a motion to fund the case will be voted on at the next meeting. Pictured is an illustration of a pound net. These nets are 1,200 feet long each and stand to have a tremendous impact on the enjoyment of the beachfront. This is an extremely important issue and I encourage you to come out and offer your support.

Golf Cart Etiquette

Exercise good judgment when using golf carts in Ocean Park. See the information below.

In a recent communication with James Spore (City Manager) "City Code 6-12 prohibits any vehicle of any kind to operate on the beach including golf carts."

This, of course, does not apply to city vehicles operated while cleaning or working on the beach, the police and emergency vehicles, erosion commission vehicles, vehicles of net fishermen operating under proper permits.

"Walking and climbing on the dunes and golf carts going over the dunes and children climbing on the dunes and pulling out the grass— City Code 6-14 — prohibits these actions."

Should a handicapped person wish to use a golf cart on the beach, they should secure a letter from their physician stating their condition and send this to the City Manager requesting permission to use a golf cart. For further information, call 385-4242.





Virginia Beach marker remembers area's early residents

The highest natural ground in the city is a 30-foot bluff on the south shore of Broad Bay, across the water from First Landing State Park. It was here, where the Pleistocene-era landform known as the Pungo Ridge crests in today's Great Neck, that much of the region's native population lived - and died - before the arrival of Europeans. In 1980, the city's residential building boom reached the undeveloped wooded ridge. Richard Fleming's parents were the first to build there.

Fleming, then 26, was back from college that summer with a bachelor's degree in anthropology. He unearthed Indian artifacts as builders started construction on his parents' waterfront house. Pottery shards, a trash pit, and then, bones. He called state archaeologists who would later describe the site as one of the most significant in the mid-Atlantic.

"There's a burial about right here," Fleming said Wednesday, pointing down at the backyard deck at the home he now owns. "That window over there," he said pointing to a corner bedroom, "they found a burial while excavating the footings."

Inside the house, he rummaged around, finding two black-and-white photos. In one, a full body skeleton, immaculately preserved in its grave, lies face up.

In the other, a partially crushed skull is depicted in profile. Fleming guessed it was damaged by construction machinery. In all, archaeologists found the remains



of 64 people. Some bodies were clad in copper bracelets and beads. Before Fleming's discoveries, amateurs also dug around the site. A Norfolk man named Floyd Painter in 1981 found a body he called the "King of Great Neck." It was covered in 30,000 beads, he wrote.

Archaeologists determined the bones were those of the Chesapeake Indians, who were massacred by the Powhatan tribe around the same time Jamestown settlers arrived in 1607. The bones spent years in a government office in Richmond before members of the Nansemond tribe, led by former Chief Oliver L. Perry, persuaded state officials to return them home - or at least close.

In 1997, the remains of the 64
Chesapeake Indians were buried across the water in First Landing State Park. A grassy mound surrounded by a split-rail fence marks the spot. On Wednesday, state officials recognized the Chesapeakes with the dedication of a historic road marker to commemorate the tribe. The marker will be installed later this year on Thomas Bishop Lane, the road

Fleming lives on. Today, the street is home to small mansions with commanding views of Broad Bay, well-manicured lawns, and expensive cars in the driveways.

In the time of the Chesapeakes, the tidal flats and brackish marshlands provided the tribe oysters, crabs and fish. Deer roamed in dense forests, and the natives grew blueberries, strawberries and hickory nuts.

"They didn't just live here," said Fred Hazelwood, First Landing State Park manager. "They thrived here."

The sign dedication was a reunion of sorts for archaeologists who worked at the site they call "VB7." For many, the work they did there was a career highlight. "I could have literally spent my entire life there," said Randolph Turner, a state Department of Historic Resources archaeologist who led a dig at the site. "It was just remarkable."

See the items below for an update on current issues affecting your community:

THE ZONING REQUEST for a partial street closure at 3868 Jefferson Blvd. (Raleigh Avenue/Windsor Crescent beach access) has been deferred by City Council. The Planning Commission had recommended that the closure be approved. The OPCL opposed the closure. The applicant does not want to close the public beach access, but wishes to acquire a portion of the paper street to resolve encroachment issues created by a previous owner. The City is exploring the possibility of granting a partial easement or other solution to resolve the encroachments.

OPCL FINANCE COMMITTEE UPDATE: The finance committee met in March to review the Robbins Legacy Account and reinvest \$55,000 of CD proceeds that came due. The committee decided to take advantage of reinvestment opportunities in the corporate bond market and also increased our allocation to equity markets by adding a balanced fund to our allocation. Once the reallocation is complete, the account will hold approximately 78% in fixed income/cash, and equity exposure will be increased to approximately 22% from 15% on a balance of \$173,800. Several motions will be presented at the May meeting to authorize donations to various organizations from the Robbins account. Your ideas for funding of community projects are encouraged and welcomed.
