## Pleasure House Point update

Barbara Duke, senior planner with the City's Parks and Recreation Department, has been making rounds of Bayfront civic organizations reporting on the status of the acquisition of Pleasure House Point.

A couple of good news items: a bridge loan has been found to secure the acquisition — once the legal issues between Wayne McLeskey and Wells Fargo have been resolved.

This loan will have to be paid back, of course, but it gives the City more time to find grants and identify other funding sources.

The second piece of good news is that the wooded, 5-10 acre tract at the corner of Marlin Bay Drive and Shore Drive is not being considered for commercial development at this time.

#### **Pound net case update:**

Oral arguments were presented in the Virginia State Court of Appeals the week of Oct. 9.

The appeal is an attempt to establish legal "standing" for an aggrieved individual in order to challenge in Virginia Beach Circuit Court, the Virginia Marine Resources Commission's decision to allow three new pound nets to be installed off Ocean Park and Chesapeake Beach in 2009.

A decision from the three-judge panel court is expected sometime in the next few weeks.

## **Dredge Transfer Stations Back on Radar**

The Beaches and Waterways Advisory Commission held a public meeting Oct. 13 at the Great Neck Recreation Center, to hear public comments about the proposed Neighborhood Dredging Plan outlined by the City in a Sept. 10, 2010 Policy Report to City Council.

The complete report can be found at www.vabeach.com under the Neighborhood Dredging. The following excerpt is from the title: Neighborhood Dredging Special Service District Policy Report.

## Recommendations from Report: The City's Case

For neighborhoods desirous of dredging along private waterfront properties, the City proposes the formation of Special Service Districts (SSDs) to fund dredging when the City performs its spur channel dredging, which is a normal responsibility of the City.

The proposal includes City management of the projects and cost sharing to cover the contracting and administration, but only offers these service to communities that are will to fund the projects through binding taxation.

It is understood that 24 months is required upon Council adoption of the SSD to conduct the engineering, surveying, permitting and contracting, as well as allow the SSD fund balance to grow in advance of the first dredging.

Though this is a resurrection of previous initiatives founded on City/
Neighborhood cost participation staff supports this serious attempt to tackle the continued deterioration of the quality of our citizen's waterfront property and their access to navigable channels. Secondly, it attacks the leading cause for the degradation of the Lynnhaven's water and habitat quality - siltation.

## Dredge Material Transfer Sites, and Transport Impacts:

Crab Creek and Maple Street, among others?

Given the lack of available dredged material disposal areas for hydraulic dredging, the dredging of these channels would be accomplished by the mechanical dredging method.

In brief, the channels will be dredged using a barge mounted excavator, with the dredged material being loaded onto barges for transport to a transfer sta-

#### The Residents' Response: On Maple Street & Crab Creek

Summarizing the comments

Nothing has changed with respect to the objections to the location of a Dredged Material Transfer Station (DMTS) at Crab Creek. It remains to be seen what effect the new Lesner Bridge configuration will have on accessibility at LBR, but the City has said that LBR will remain operational.

The Beaches and Waterways Advisory Commission is recommending that dredge material transfer operations be curtailed during certain sport fishing periods, weekends and holidays, and that operations be limited to 30 truckloads a day for no more than a 90 working day period, and for no more than two 90 day cycles per year.

In addition, the Commission is encouraging the City to examine more closely an alternative site for the Maple Street Transfer Station. Residents near both proposed sites have two primary objections, over and above the objections raised during the discussion in 2007-2008 of the LBR (Crab Creek) DMTS.

Rejecting an accusation applied to them, the opponents of the Maple Street and LBR DMTS locations claim that their objections are not NIMBY (Not in my Backyard.) It is their feeling that they are being asked to bear the burden of the private dredging, without any benefit to them. No gain, all pain. If anything, they feel that the upscale waterfront owners are the NIMBYs. (It is to be noted that Robin Hood Forest has stated that they will not need to use the DMTS; opting to truck through their own neighborhood. There may also be others, but Robin Hood Forest has the advantage of roads suitable for haul traffic.)

Additionally, some of the homes along the proposed truck route are earth-shakingly close to the truck traffic, which will render their backyards unusable during transfer cycles. And of course, all the old arguments remain from fishermen, boaters, kayakers, environmentalists, commuters and taxpayers who came forward when Crab Creek was on the table before.

## The Good, The Bad and the Not So Pleasant:

The good news is that the City is taking a big-picture, long-term approach to the situation, which is the best form of government. The bad news is that the burden and benefit of these projects do not seem to be equally shared. Only a brilliant, unorthodox solution can keep this from becoming a not-so-pleasant scene. Let the dialogue continue. With more civility, please.

## Rash of robberies in Chick's Beach

Police are increasing patrols, and urging residents to make sure their homes are secured.

Editor's note: Between Sept. 13-Oct. 4, there were seven burglaries and two attempts in the Chick's Beach area. Virginia Beach police believe these burglaries, are connected to a string of others that have happened in the area, in recent weeks.

VIRGINIA BEACH, Va. (WAVY) - Residents in the Chick's Beach area of Virginia Beach are locking up after a rash of burglaries have hit the neighborhood.

Virginia Beach police said the burglaries span from Lake Smith to the Lesner Bridge. Detectives believe at least two burglary rings are behind the crimes. According to police, the thieves park their vehicles, ring the doorbell and enter homes from the back.

A flyer is circulating around the neighborhood warning residents to be vigilant. "I got a notice about a burglary in the neighborhood, and it was so close to my house..they want me to see it. So, I read it and got a little frightened," said one Lookout Road resident who asked not to be identified.

According to police, the thieves park their vehicles, ring the doorbell and enter homes from the back.

Police urge people living in the area to lock up, even when they are home and look out for each others' homes and safety. One victim said the burglars came through his window and stole computer equipment and firearms. He said on September 13 someone jumped his privacy fence, opened a window and stole from his home. The suspect left with two laptops, three cameras, a pistol safe with a weapon inside and a camcorder.

The victim added, "everything they stole I earned with my own money. I've been deployed. That's deployment money buying nice things so I can go to school. They stole the computer I had all my school work on."

"All new dead bolts and security systems going up. Neighbors are telling me about different security systems out there. We've certainly upgraded and we're definitely keeping an eye out," he said. He added one neighbor has even installed security cameras, "it's a shame you have to worry about that sort of thing when you're out working, making money."

## Developers scale back condominium project at former Duck In site

lans to develop on the old Duck-In site, vacant since the oncepopular seafood restaurant closed in 2005, are changing. The restaurant was demolished a few months after it closed, although the gazebo remains.

Local developers purchased the property in 2004 and proposed building Point Chesa peake, a \$100 million condominium complex. Plans for the development consisted of 158 condos, ranging in size from 2,000 to 4,000 square feet, which would be housed in several buildings eight to 10 stories high.

But, the project stalled after the housing market hit a downturn. For the past several years the developers – Terry Peterson Cos. in Virginia Beach and Napolitano Homes – have sat on plans to develop the property.

"We knew they were going to be more expensive than what the public was going to pay," said Tuck Bowie, president of Terry Peterson Cos.

The new proposed project is scaled back. The plan calls for fewer units and smaller buildings that are four-stories high.

Earlier this year, the developers submitted paperwork to redo the site.

"They're working to amend their plans," said Karen Lasley, zoning administrator with the city's Planning Department. "They had something approved, and they're talking about changing it since the economy's changed."

"We're getting it more in line with where the market is today," Bowie said.

The city just received \$85 million in state funding to pay for replacement of the Lesner Bridge. The aging bridge, which borders the Shore Drive property, has some technical issues associated with the new bridge design that have to be resolved before Bowie will know exactly what the finalized condo plan will look like.

Once the technical issues with the bridge design are resolved, Bowie said, he will file for a new conditional-use permit for the updated project. If the project is accepted by the city, construction would not begin until after the completion of the Lesner Bridge's new west-bound lanes, unless the housing market quickly rebounds.




