City Council Informal - 03/21/2023

Unfunded Needs and Delayed/Deferred Projects

- Insufficient funds to meet additional funding requests for new projects totaling more than \$155 million
- Insufficient funds to complete or fully fund 9 projects as reflected as in prior year CIPs
- To complete, \$140+ million would have been necessary.
- Delaying/Deferring these projects allowed the redirection of resources to put toward projects closer to construction timeline or to meet state/federal obligations



SHORE DRIVE PHASE IV IMPROVEMENTS CIP 2-118

- 0.6 mile segment from Marlin Bay Drive to East Stratford Road
- Retains 4-lanes—no capacity expansion
- Includes safety improvements, edge treatments, and multi-use paths
- Currently at 15% design
- Total Project Cost: \$14.2M
- Construction Start—September 2023

- **Oct 1997:** Bayfront Study (Shore Drive Corridor Study) performed
- **Feb 1998:** Shore Drive Advisory Committee (SDAC) created
- **Aug 2000:** Shore Drive Transportation Study initiated
- **Jan 2002:** Shore Drive Transportation Study presented to Council
- **Jan 2003:** Shore Drive Demonstration Project design begins
- **Dec 2005:** Council establishes the Shore Drive Safety Task Force
- **May 2006:** Council approves \$1M funding for interim improvements
- **Sep 2006:** Construction begins on the Demonstration Project
- **Nov 2006:** SDAC renamed to Bayfront Advisory Committee (BAC)
- **Jan 2007:** Shore Drive Phase II, III, & IV Projects established by Council
- **Apr 2008:** Construction is completed on the Demonstration Project
- **Dec 2008:** Phase II, III, & IV plans advanced to 30%
- **Jul 2010:** Shore Drive Phase IV Funding transferred to Phase III
- **Jan 2015:** Bayfront Advisory “Committee” changed to “Commission”

Description and Scope																		
This project begins at the Marlin Bay Drive and Sandy Oaks Drive intersection and ends at the west end of the Lesner Bridge. This project will improve vehicular and pedestrian traffic flow and safety in the roadway and intersections; improve storm drainage; include a multi-use trail, five-foot sidewalk and on-street bike lanes; and enhance the corridor with aesthetic elements such as landscaping and lighting. Existing aerial utilities will be relocated to a combination of underground locations at intersections and to new overhead locations along the rest of the project corridor.																		
Purpose and Need																		
Shore Drive is a major east-west arterial in the northern portion of the City. The existing roadway carries 38,800 vehicles per day with a current capacity of 36,900 vehicles per day. Without this project, the roadway will continue to experience vehicular, bicyclist, and pedestrian safety incidents, and restrict traffic volume due to inadequate stormwater drainage.																		
History and Current Status																		
This project first appeared in the FY 2007-08 CIP. On January 9, 2007, City Council established this project with the appropriation of FY 2005-06 fund balance from the General Fund. This project was placed on hold at the Bayfront Advisory Committee's request to re-prioritize "Shore Drive Phase III" in place of this phase. In the FY 2020 CIP, funds were appropriated to this project to initiate project design activities. The Commonwealth Transportation Board has awarded this project \$500,000 in Revenue Sharing in FY 2024-25. As an existing Revenue Sharing project, "Shore Drive IV" will receive priority in the next round of Revenue Sharing Awards, currently anticipated to be in the out years of the VDOT's Six-Year Improvement Program and CIP. Therefore, Commonwealth funds were increased in the project and local funds in the outer years of the CIP were redirected and reprogrammed to "Centerville Turnpike Phase II." Outer year funds have also been re-directed to - Elbow II-B; Elbow II-D; Parliament I; Nimmo VII-B and Pungo Ferry projects in the FY 2022-23 CIP.
