Perspectives

The group of police managers, who are associated with the Virginia Beach Police Department, made a fatally flawed decision by issuing the new policy of "non pursuit" relating to crimes defined in the Beacon, August 9, 1998.

Should the Virginia Beach Council and the citizens of our city permit this policy to stand, we will all lament that decision.

The City of Virginia Beach is noted worldwide as the safest city in America for its size. Any change in police policy that will allow criminals to come here and leave comfortably and will signal we are a municipality where crime is permitted to flourish. Criminals of every breed will recognize the

vulnerability of the city's police department.

Chases by the police should be unequivocally permitted and encouraged. Since our city is an exceedingly safe city, it is in part, because law enforcement officers are conscientious and well trained. They will, we hope, maintain good judgement and break off a pursuit when the safety of the public is threatened thus avoiding any unfortunate incidents. We must maintain full faith and confidence in our primary protectors of the law.

We strongly urge council members and the police department to continue its policy of safe pursuit in enforcing all infractions of the law where a pursuit is a fundamental part of apprehending lawbreakers.

**Tax Exempt Status for

Since we continue to use volunteers to distribute the newsletter the problem has been on hold for 2-3 years. However, it would be nice to

have the capability to economically mail the newsletter.

Dues Are Always Due

A robust membership in the Ocean Park Civic League enhances our power to conduct our locality's business with influence and determination.

Membership dues of five (\$5.00) per year are used for civic league expenses, which are minimal. The civic league maintains a contingency fund. The intent and purpose of this fund is for use when major issues confronting our sector of the city arise---and they often do. In years past, the fund has been used for legal fees in two petitions to obtain sand for our beaches and to acquire beach property in a very convoluted land matter. This contingency fund was used to keep a go-go bar from becoming part of the make-up of Shore Drive. Another time the fund was used to restrain the closing hours of a dubious bar at the same site. In all matters, we were represented by counsel. We urge you to support your civic league. FIGHTING CRIME IN OCEAN PARK

Ocean Park is continuing to experience burglaries, thefts, car break-ins and vandalism. Teenagers drinking alcohol in the streets is common place in the some parts of the neighborhood. In some cases, teenagers are assembling in groups of 8 to 10 and drinking in the street and yard of some of the teen's homes. In most cases, the parent(s) are not home. The lack of parental supervision, combined with an environment conducive to such activities, attracts more teens into our area from other areas. It is my opinion that these groups of teens and their friends may be responsible for some of the problems that we are experiencing in our neighborhood. The recent shooting of 5 at a party in Ocean Park on 10/24 may be indicative of this. The shooting occurred at 11:30 P.M.. The alleged shooter and 2 of the victims were 18 years old. How many others at the party were under 21?

Our community has to become much more proactive in dealing with these issues, or the problems are going to get much worse. Ocean Park needs to implement a Neighborhood Watch program, in conjunction with the local police department. While the program will take time and effort initially, the rewards are well worth it. The Civic league has discussed the Neighborhood Watch program in the past; however, due to a lack of involvement and commitment on the part of the community, the program never got off of the ground. It is time for the Civic league and the residents of the community make a commitment to establish the watch program. Please contact myself or Jim McElligott at once to see how you can assist your community.

In the meantime, I would recommend that we do the following to help combat the problems that are occurring:

1. Be aware of all strangers in the neighborhood and immediately report suspicious activity to the Police. Suspicious activity includes such things as individuals walking in others' yards and around houses and garages, loitering in the streets, looking into cars, etc.
2. If you suspect teens are drinking in their cars or in the streets, call the police.
3. Ensure that your homes are secure. Do not leave garage doors or utility rooms or sheds open while unattended.
4. Be aware of your environment, who is coming and going around you and what they are doing.
5. Alert your neighbors if you are the victim of a theft or if you have seen suspicious activity.
6. Do not leave valuables in your car. That includes cell phones, money, briefcases, CDs, checkbooks, wallets, tools, etc.
7. Ensure that your property and automobiles are well lit at night. Motion detector flood lights are a good deterrent.

I am hopeful that we can institute a Neighborhood Watch program in the near future. If you have any comments or suggestions, please call me or Jim McElligott. We welcome your thoughts.
