

Over several decades, through her effective combined energies, her enduring set of ideals, and a resolve to do the best for people and the community she helped fashion Ocean Park, our treasured enclave by the sea. The City of Virginia Beach became a better place because of the contributions she made to it, and a myriad of civic organizations.

She has been the epicenter of many committees, and organizations, namely:

- Judy served as president of the Ocean Park Civic League. She molded it into the marquee organization it is today. Her leadership is an inspiration to the younger people who officiate in the civic league today
- The City appointed Judy to serve on the new Lynnhaven boat ramp project which is now under construction.
- She served on the Shore Drive Advisory Committee.
- A member of the Daughters of American Revolution (DAR).

- Board member of the Francis Land House.
- Member of the Ocean Park Woman's Club. Served as the president from 1994 to 1996. While serving, she sponsored the Virginia Beach "Kids Voting Virginia", which allows children vote in the back room of each election. Served as the legislator chairman.
- The first woman appointed to the Virginia Beach Board of Zoning Appeals.
- An active leader with the Girl Scout Organization.
- She encouraged the City to purchase the Ocean Park beach property from the person who owned it, thereby, starting the sand replenishment projects saved our eroding beaches. We enjoy those beaches today.

Members of the Ocean Park Civic League feted Judy at a "Farewell Reception" at the Ocean Park Volunteer Fire and Rescue Building on August 23.

August 27, 2001

The monthly meeting of the SDCC was held at the Ocean Park Fire Station. In addition to the general officers' report, liaisons from Beaches and Waterways and the Shore Drive Advisory Committee gave reports on latest developments. There seems to be an overall lack of communications among City government offices and City Council and various sub-committees. Several ideas were brought forth to improve sharing information.

Mr. Bill Miller also shared a letter he had written to all involved with the proposed expansion of the Lesner Bridge. It seems the consulting firm did not consider any costs or impact of aligning the new bridge to the south of the current site. All studies and drawing show a slightly northern alignment to the current spans. He was asking for fair consideration of all possibilities before Council makes a decision. It was agreed that contact must continue to be made with Council to insure that our interests are truly represented by any decision made by them.



Virginia Beach's emergency medical services are provided by a group of eleven rescue squads operating thirty ambulances throughout the City, the Ocean Park unit being one of them. However, the Squad owns the building and land in which the Ocean Park ambulances and fire equipment are stationed. It is an asset to the community.

After many years of use, major repairs are needed. The difference in cost between a major renovation and enlarging the building is not that great. An enlarged building seems preferable to accommodate the new equipment to service the increased size and height of buildings in this area. Proper fire equipment rapidly deployed may save your property. A large multipurpose room in the building also serves as a meeting place for several civic organizations. ## THE SHORE DRIVE CORRIDOR

The overall physical character of the Shore Drive corridor is viewed as an area that has evolved in a very uncoordinated and uninspired fashion. Nevertheless, as has been shown through the recent findings of an advisory panel's study, numerous opportunities still exist to transform this area into a special place with its own character, while also making it a memorable gateway to the oceanfront resort area. Changes need to be made regarding the relationships and design of land uses, alternative modes of transportation, and beach management. These improvements are underway.

## OCEAN PARK BEACH SAND REPLENISHMENT TO BEGIN MID-SEPTEMBER

The bid has finally been awarded. Dredging work will begin mid-September. A letter received from Mr. J. Bernas, Office of Beach Management, City of Virginia Beach informs us that: "Dredged sand from the Lynnhaven Inlet will be placed on the Ocean Park beach between the Lynnhaven Inlet and Rookery Way." The project was originally scheduled to begin during the second week of August. Approximately ninety days will be needed to complete the project.

During this time, the contractor needs your cooperation to assure that all Hobie Cats and other boats are removed from the beach. Boats left on the beach or dunes may be towed at expense of the owner. If you know of anyone who may have a boat on the beach, please advise them to remove it. Help by keeping the beach "cat-free" during the entire length of this project. Once the project is underway, sections of the beach will be temporarily closed. To ensure public safety, security will be provided to limit public entry into the work area. Please keep in mind that any temporary inconvenience will be worth the end results.

We are fortunate to be scheduled for this work by the Corps of Army Engineers. The Ocean Park Civic League extends its thanks to Mr. Bernas and his office for their work in making this happen.




### Multi Use Trail- Bike Path Part of the Shore Drive Beautification Initiative.

The City of Virginia Beach is receiving a \$150,000 grant for the trail-bike path. This is a welcome recreational addition. It runs from Marlin Bay Drive to East Stratford Road.

## LYNNHAVEN INLET BOAT RAMP AND BEACH FACILITY

Work on this new addition to our area is continuing on schedule. The contractor North Star Construction Corporation, who is building the facility, keeps our civic league informed of their progress. Piers and pilings are in place. The information center and rest rooms are taking shape. A completion date is tentatively set for November 12, 2001.
