Message from the OPCL President on Page Two

Message from the OPCL President

Chris Hendricks

Greetings, Neighbor: Let's start with introductions for those of you who do not know me. I am Chris Hendricks, your new President of OPCL [Ocean Park Civic League]. Our Board and officers were elected on May 6th, so our upcoming meeting on Sept. 9th will be our first with the new slate. We will report on "the first 100 days in office" and will need your votes on some important issues. We will have lots of information on neighborhood doings. Please come. Please join, if you haven't already [\$10 per household]. Please come and vote!

The Board [including its officers] has been hard at work in two areas: structural issues and neighborhood issues.

Structure:

1. We plan to change the Board structure which will require a **full session [plenary] vote** on a by-law change on Thursday. We propose to add up to three seats to ensure representatives from Aries on the Bay [AOTB], Three Ships Landing [TSL] and the two high rises have seats on the Board. We need representatives to speak for these communities and let their neighborhood associations connect with OPCL issues. In addition, we will have a chance to handily add 300-400 petition signatures for petitions through their block captain systems so, when issues arise, we can even more effectively organize. In the end, we hope to have a larger group of involved citizens in our civic league, as it should be.
2. We hope to be ready to present a rewrite of all our bylaws. It's been years since they were written and they are quite inadequate. Drafts will be available on the web at www.opcl.org and at the OPCL meeting, Thursday. We owe a debt of gratitude to Susan Karlau, Special Projects Manager, who researched other civic leagues and associations to create her revisions which were accepted by your Board, but still needs a **full plenary vote**.
3. We split the previous secretary/treasurer position held by Anne Kane, into three positions on the Board. We keep the awesome Anne Kane as Treasurer, focusing on fiduciary responsibilities and as OP's rep on some regional committees and added two spots: Grace Moran, Secretary, and we will vote in a second one, to assist Grace, on Thursday. Grace has been instrumental administratively in merging and getting letters to the City Council and The Mayor, and in providing timely minutes to our meetings [posted on our web-site] among other efforts behind the scenes. These changes and assignments are examples of structural improvements to make the Board more effective to respond to unexpected problems, handle new duties, and keep the stress level lower for our wonderful volunteers.
4. Further, we have assigned other collateral duties to our Board group. Your Vice President, Dave Metzger, is assigned to handling zoning hearings, new zoning initiatives [R5R], and the development issues of Ocean Park particularly in representing Ocean Park's best interests regarding the next developer planning to do things at Pleasure House Point. His expertise in real estate and contacts in City Hall make him perfect for the job. Billy Sykes, who remains on the Board as Past President, supports Dave on developments; is dealing with OPCL's title to new property that has just become ours; and uses his legal skills to edit the proposed by-law changes. These are some of the highlights of modifications. We could do more and we invite you come lend a hand.

5. Editor, Carol Collins, and Publisher, Jean Sleeman have massively improved our **newsletter**, as you can see. Board members Stuart Terrel and John Wigmore are assisting in advertising sales. While several of us write articles, we still seek contributors. This is our main communications tool for our estimated 1800 neighbors. We are also awaiting a proposal to upgrade our website [which will require a full session vote].

I want to add that your Board does an excellent job of keeping your best interests in mind when voting and contributing to Board actions and recommendations.

Please note: Several volunteers are still sought for positions advertised in this issue. Join us! Make a difference in your neighborhood and help us. We are fun to work with.

Neighborhood Issues:

1. Letter to newly elected/current **City Council and Mayor**: we wrote a letter to City leadership outlining the new officers and our strengthened structure. We pointed out our top concerns:
 - a. Pleasure House Point development plans.
 - b. Need for open space as per the City plan for this neighborhood.
 - c. Inappropriate zoning requests within Ocean Park and inconvenient hearing times for us, who work. These times are good for developers and bad for residents.
 - d. Opposition to any expansion of Shore Drive.
 - e. We also expressed interest in meeting and working with The City.
2. We hear rumors of another developer for **Pleasure House Point** [see Dave's report in this issue and full report on Sept 9th]. Now that correspondence has been established with the City, the Board expects to enjoy fuller communication with city leadership. Therefore, VP Dave Metzger has sent a letter to City Hall expressing Ocean Park's interest in being involved in the planning process with the rumored new developer. **This is our top neighborhood priority and we will keep you posted.**
3. OPCL about to take title of **3608 East Stratford Street**, across from Jimmy's Pizza: We have a report in this issue and one for the meeting. Andrew Broyles leads a committee and a legion of helpers [some are Board members] on the Stratford Property Development Committee [SPDC]. They are working hard to collect information and numbers so the Board may take a recommended action, after comparing findings, so as to decide to put a choice up for plenary [full] OPCL vote.
4. **Osprey Point Park** planned: We will have some information about a park planned to be developed south of the boat launch ramp.
5. **Traffic Committee:** We would like to form a committee to improve safety and slow cars down a bit, by working with city officials.






Volunteers Needed for New Positions





Summary of the Minutes from May 6, 2004 Meeting

Grace Moran, Secretary

Meeting called to order by Billy Sykes, Pres. The first order of business was a discussion of the property at 3608 E. Stratford Rd, which is currently rented. Title is in the process of reverting to OPCL. The structure is in need of repairs and the options regarding the property presented by Andy Broyles are as follow:

1. Remodel the present structure. The estimate to repair the outside is \$25,200 which does not include hidden damage, nor has the inside been assessed.
2. Demolish the present structure and build a multi-purpose structure which could function as a business on a daily basis and a meeting and conference center for the OPCL. This would require rezoning from the property's present R5D status.
3. Sell the property. Present market conditions suggest a \$225-235K sale price.

Concern was expressed regarding the variances required to execute Option 2. From the floor came Option 4 – Demolish the current structure and plant grass with the intent of revisiting the future development at a later date. Motion was made and seconded to form a committee to conduct further study and refine plans for future development.

Next was the update on Pleasure House Point. Billy Sykes reported that Stanley Tseng still has an option to buy and develop the property. OPCL has enlisted the sponsorship of councilman Louis Jones in petitioning the city to use city funds to purchase some or all of the property as open space and both are awaiting the outcome of recent elections to present their points to council. Meanwhile the city's open space fund is dwindling.

Chris Hendricks then brought up the newly reinstated OPCL Newsletter as a means to attract, inform and retain members of the community. The Newsletter has resumed under the direction of Carol Collins and Jean Sleeman. Their recent efforts were acknowledged and members are encouraged to submit articles.

Tim Solanic announced that the Website has been revamped and is now online at www.opcl.org.

Visit the website to get an update on the Live Oak Sapling Preservation effort. The city has designated the live oak as the city tree.

Anne Kane presented the Treasurer's Report. There is over \$2,900 in the checking account and \$11,500 in the savings account, income coming from rent, dues, donations and advertisers.

The slate of officers for the 2004-2005 year was presented. Chris Hendricks, President; Dave Metzger, Vice President; Anne Kane, Treasurer; Susan Spears and Grace Moran, co-Secretaries; Stuart Terrel, Northside Representative; John Wigmore, Southside Representative. There were no nominations from the floor. The slate of proposed officers was accepted unanimously.

Note was made of the handicapped-accessible walkways the city has introduced to the bayfront on Albemarle and soon on Sandalwood. A need for someone to place the meeting signs was expressed and Dave Metzger agreed to handle the responsibility.

Chris Hendricks offered an overview of his vision for OPCL in the coming year. Anne Kane announced the city's plan to hold a meeting regarding the bike lanes across the Lesner Bridge.



A committee named the SPDC has been formed and has met 3 times since its beginning in May 2004. The purpose of the SPDC is to provide information from which we can make an objective decision regarding the repairing, remodeling, razing or rebuilding of the property recently discovered to be owned by Ocean Park Civic League at 3608 East Stratford Road. The group is Chaired by Andrew Broyles, Vice Chairman is John Wigmore, Secretaries are Jim and Sharon Need. The following five committees and members have been established: Insurance Committee - Mike Corvigno; Legal Committee - Lew Mabie and Susan Karlau; Tenant Committee - Anne Kane,; Construction Committee - Andrew Broyles and Tim Solanic; Municipal Committee - Dave Metzger; at large Nancy Koch, Jean Sleeman and Mike Wills.

The SPDC is preparing a presentation to the Board of Directors and the Ocean Park Civic League for discussion in the months of August and September. Once the Board has discussed the options and come to some decisions, the recommendation will be brought before the entire membership for a vote. The Board is currently addressing the first priority of obtaining clear title to the property in the name of Ocean Park Civic League.

The Civic League thanks the committee for their diligent efforts in thoroughly assessing all the issues and options.



RECIPES

OREO COOKIE PIE

1 bag Oreo cookies (regular, not double-stuff)
 3 squares unsweetened chocolate
 1 stick butter (melted)
 3 whole eggs
 2 cups sifted confectioner's sugar
 1/2 gal Breyers vanilla ice cream (softened)
 1/4 cup cream de menthe

Crush 25-30 Oreo cookies and spread in bottom of 9" x 13" glass pan.
 Heat unsweetened chocolate and butter until melted (Do not cook - or boil)
 Add eggs and stir in sifted confectioner's sugar until mixed together (Do not over heat)
 Pour melted fudge mixture evenly over Oreos in glass pan and freeze until set - approximately 1 hour.
 Mix together ice cream (softened) with cream de menthe.
 Spoon (or pour) over top of fudge mixture and top with 5 crushed Oreo cookies.
 Cover with aluminum foil and freeze overnight.
 Serve frozen.


