CALL TO ORDER:

Chair Bob Magoon called the meeting to order at 3:33 P.M.

MOTION TO APPROVE THE MINUTES FROM 1/16/24 MEETING:

Motion by Mr. Hearst, seconded by Vice Chair Lindemann. The meeting minutes were approved unanimously.

Mr. Trower and Ms. Wong arrived at 3:37 P.M.

CHAIR'S REPORT:

Mr. Magoon introduced Chuck Cayton, RAC chair, and talk about the desire to the build a a shared vision for the coastal areas of Virginia Beach. Stated he's been attending BAC Design Committee and Infrastructure Committee. Introduced new member John Maas and CAO Rep Diamond Royster. Mr. Cummings announced there will be funding for the Shore Drive CIP project on eastern side of the Lesner Bridge (Phase 3) and is excited and aware of the intensity of construction for the 3-year scope. JB Maas introduced himself and his background and relationship to Virginia Beach

PRESENTATIONS/DISCUSSIONS

Dominion Energy – Line 27 Electric Transmission Line Rebuild Project Update – Mr. Rick McClean

Goes from Burton, Bayside, Long Creek, Bains Store, and then the VA Beach substation (12.7 miles) using existing ROW

Will be talking to property owners where poles fall onto their property and the whole process.

There will be public open houses periodically with staff and crew of Dominion Energy (next in August 2025)

Mr. Davenport asked if the mailers were only be included for those adjacent to the project or to the entire neighborhood. Mr. McLean stated it depends on the project and folks who know are in a different department.

Mr. McLean said he can send the info to the BAC to send to the greater community.

Metal poles will be sturdier and installed deeper into the ground than current wooden ones.

Dominion Energy website has a portion for community notice called Backyard Neighbor; it will be posted on BAC website.

Councilman Schulman thanked Dominion Energy for their communication with Council and about additional limitations

2) Pleasure House Point Native Plant Harvest

Harvest was a collaboration between City, LRNow, friends of live oaks, and Chesapeake Bay Foundation.

Surveyed 5000 trees and marked saplings for LRNow, 650+ taken to VT Garden Center for inventory.

340 total volunteer hours completed for this project

The Live Oak tree situated on corner will be saved thanks to Student data and this project by shifting the design and location of the construction entrance to the site.

Mr. Davenport commended the efforts put in. He asked if any of the grasses retrieved would be placed on dunes. Kristen said these wouldn't be appropriate for dunes as these are for riparian areas, but LRNow has recently restored some dune grass.

Councilman Schulman echoed thank and stated how many of these stakeholders were included based on responses of the public to ensure best practices were taken.

Councilman Cummings also echoed thanks.

During Public Comment: Members of the public shared their concerns about:

Wild animal and habitat destruction

Whether trees can be taken by the public from this area

Concerned about wetlands grass being removed. However, the grasses that were removed (Phragmites) are considered invasive and may be removed via a permit from the State, which is what occurred in this instance.

What happens with turbidity of the water, will there be an impact on oyster reefs?

Why weren't credits purchased beforehand, what was going to happen if credits weren't obtained, what happens if flooding happens in meantime?

Mr. Trower wanted to relay that beach season is opening and mindful of cleaning up beach accesses
