EXECUTIVE COMMITTEE MEETING REPORT

The following proposal was received from Hobie Fleet 32, INC., recommending that Albemarle Street be opened to assorted watercraft that utilize the Ocean Park Beach. Your Ocean Park Board has reviewed the proposal and its implications for the long term and are against the opening up of Albemarle Street for this purpose.

Although we don't object to Hobie Fleet 32's intent to be good citizens in wanting to tag watercraft and clean the Ocean Park Beach from the Lynnhaven Inlet to the Baylake Beach, we object to Albemarle Street being a launching site for the City of Virginia Beach. This is a heavily populated area. Streets are too narrow and there are "No Parking" signs posted. The locked gate on Albemarle Street is for access of City of Virginia Beach vehicles.

We solicit your help and support in preventing the City from adopting this proposal from Hobie Fleet 32, INC.

"Save Our Dunes"

Sound familiar? Well, I guess it does. If you have been in Ocean Park more than 20 minutes during the past two weeks, you have heard this phrase a lot. In a nut shell, nine years ago the citizens of Ocean Park fought a long, hard battle for replenishment of primary dunes to save coastal area beach and safe guard real property in the area. They won.

Now, the construction of a new house is threatening to undo all that was fought for. At the Ocean Park Civic League Board meeting on May 6, 1997, it was decided to support a citizens' committee which would work to stop the construction at 3790 Jefferson Boulevard. The permit issued allows an on-grade structure to be built 58 feet closer to the replenished dunes than had been previously been allowed.

Commentary from the highest levels of the Virginia Institute of Marine Science (VIMS), as well as your elected officials indicate that a grave mistake has been made. Despite the genuine efforts of Councilman Louis Jones, State Delegate Leo Wardrop, and City Manager James Spore, it appears the development will continue.

Legal opinion has already been presented to the City indicating this building is precedent setting, and is, therefore, unacceptable. At this time, it appears litigation is the only option.

In light of this, the Ocean Park Civic League Board of Directors has recommended that interested citizens contribute whatever funds they can to the SOD Legal Fund. If you would like to assist, please send your checks to the Ocean Park Civic League, SOD Fund, Post Office Box 55385, Virginia Beach,

ATTENTION JET SKIERS!

On May 7 the Ocean Park Civic League sent a letter to Police Chief Wall requesting vigorous enforcement of City Ordinances #2317 (11 April 1995) and #2333 (06 June 1995) summarized as follows:

During the period of May 1 through October 15 of each year, from 10:00 a.m. until sunset in the area adjacent to the beaches of Chesapeake Bay and extending 100 yards seaward from the shoreline; and from Little Creek Amphibious Base to Fort Story, it shall be unlawful for any person to operate a motor craft (including jet skis) *except* when proceeding to or from the beach or an anchorage at an angle perpendicular to the shoreline at a minimum speed to maintain steerage and headway and while maintaining a distance of 100 feet from any person in the water.

Copies of the letter to Chief Wall and the ordinances will be available at the June 5 meeting.

WHEN IS A PUBLIC BEACH NOT A PUBLIC BEACH?

If you are one of those who would like to have this access, if you have a good alternative idea for small craft, if you are an irate citizen and want to "tell it like it is", June 5 is your golden opportunity. Whether for or against, you will have an opportunity to convince the community that you have the correct solution to this problem.
