SHORE DRIVE COMMUNITY COALITION

Overviews of meetings held February 26 and March 26, 2001

We have a spokesperson (a.k.a. "stakeholder" representative) to the recently formed Shore Drive Community Coalition (SDCC.) As such, I am your voice to a group that has come together to represent the Shore Drive area to the City of Virginia Beach (and other agencies and groups) to better the quality of life in our community. We strive to represent the corridor in providing proactive assessments and reactive solutions to civic issues that concern us. We are also eager to organize and encourage participation in annual local events that promote community friendship and camaraderie. Finally, we work to be the effective communication tools for the Shore Drive corridor.

My apologies for the paraphrasing to the people who labored to write very specific and politically correct by laws. I have enormous respect for those who know how to make our voices counts. I want to represent all the people of Ocean Park. Communication ... that is what it is all about! So, share your ideas, concerns, and opinions. That is why you have my home phone (363-7321) and my E-mail (Akten@aol.com)

The major business of SDCC these days is to gather enough people to voice our opinion to City Council that there is no need or desire to widen Shore Drive to six lanes. Although the SDAC (council appointed) and the residents (SDCC) have recommended against it, and the Shore Drive Transportation Study decided to delay their report for about three months (based on public outcry?)... City Council has already budgeted money to fund this program. The plan calls to widen Shore Drive from First Court to the western approach of the Lesner Bridge. Currently they are proposing \$2mil (\$2,000,000) over the next three years (coupled with a \$16 mil of State funding) for a road project that would lead to a major back up at the Lesner Bridge (eastbound), and Northampton Blvd. (westbound). Is this **REALLY** needed?

I encourage anyone with an opinion to let it be known.

Another issue we are working on is the City acquisition of property along the southern borders of Marlin Bay Drive. Spurred by the recent action by the City to dredge Crab Creek, this large, undeveloped area has become a ripe target for developers who see condos and boat slips. Most (all?) residents that I have heard from are quite adamant on the need to preserve this as a park, sanctuary, or a wildlife habitat. We have people talking to environmental groups that may help in our efforts. Comments? Suggestions?

We also have working groups on:

A Community Meeting Place--close off Seashell Road at Shore Drive for a community park?

Transportation / Utilities / Beautification

Open spaces

Speed limits / stop signs/traffic management

Density / zoning / development

Condo issues / trash removal



Our next meeting is Monday, April 30, 2001, 7:30 P.M. at the Ocean Park Fire/Rescue Station. Please come, if only you are curious what 32 Civic Groups along the Shore Drive corridor expect to accomplish with our resolve.

To quote a neighbor; Dave Addis, in his column of February 18, 2001, he sardonically observed, "The sin committed by Ocean Park and several other Bayside neighborhoods - Baylake Pines, Chesapeake Beach and a few others --is that they have not yet paid proper homage to the machinery of untrammeled development."

His column continues to observe his take on the plans:

"Translation: Let us widen the road, flatten those annoying little family- owned restaurants, and pave it all over with a carefully designed, artfully rendered, fully plasticized Potemkin villages that will fake folks into believing that it is a genuine Jimmy Buffet-style beachfront neighborhood that they are blasting through at 65 mph on their way to the real Oceanfront"

That is the way I see it. Please feel free to correct me if warranted. And I encourage all to voice their community concerns. Many have already raised a voice calling for some form of "civil disobedience." I think I must reread accounts of the Boston Tea Party to ascertain how the "taxed" fight for their voice to be heard.



CIVIC LEAGUE OWNED PROPERTY

At the last meeting of the Ocean Park Civic League in March, Co-president Wendy Vaughn, advised the attendees that a complaint was made against the property with a house on 3608 East Stratford Road, which the civic league owns. An unknown individual lodged a complaint with the City of Virginia Beach Department of Housing that the property was overgrown with underbrush and the building had some minor building problems. Wendy quickly organized a working party and more than a dozen residents armed with all kinds of gardening equipment showed up the following Saturday morning to clean the rear yard. They worked for more than two hours and removed all the weeds and debris.



Unknown to all who volunteered to clean up the back lot is that it was contaminated with some hideous poisonous growth—most likely poison ivy. Most of the people who volunteered their time and efforts found their skin scalded by the plants' toxins. They broke out in rashes. Some volunteers needed medical attention. The deleterious effects upon some were long-lasting.

The Ocean Park Civic League, a long-established adjunct to the community has been in existence for about 60 years. We have maintained our responsibility and remains an affirmative dimension to our community.

This building was the original fire and rescue squad station, and also served as a meeting place for the Ocean Park Woman's Club and the Ocean Park Civic League.

We did not know violations existed on the property. If we did, we would have attended to them immediately. If someone did see violations of any City codes, we believe they should have approached the civic league leaders and advised them. Should anyone observe anything indecorous on or about the property, please contact us. It is a community asset. They entrust us to maintain it and we will do exactly that with all our cumulative prerogatives.

John Wigmore, Southside Liaison, arranged to have repairs done to the building that will resolve these issues with the City. We have obtained a ninety-day extension until July 10, 2001 to do the repairs.

**The Ocean Park Volunteer Fire and Rescue Squad
dedicates a bronze plaque to honor the memory of
George C. Lyon, Sr. and Louise W. Lyon**

They came from all over the City to honor the memory of George C. Lyon, Sr. and Louise W. Lyon.

George C. Lyon, Sr. was a founding member of the Ocean Park Volunteer Fire Department, one of the first in what is now the City of Virginia Beach. He served as Chief of the Ocean Park Station from its inception in the Year of 1944 until his death in 1977-33 years.

Louise W. Lyon was the founder of the Ocean Park Woman's Club in 1944 and was a member until her death in 1999.

Both gave unselfishly of their time and effort for the betterment of the Ocean Park community and the Ocean Park Volunteer Fire Department and Rescue Squad. They were model citizens and always illustrated compassion. They met the high calling of community service and today remain a legacy to all of us in Ocean Park. The recognition of this outstanding couple was celebration of two marvelous lives and an acknowledgment of their commitments and contributions.

Life Member of the Ocean Park Volunteer Rescue Squad Frank Shield, welcomed the guests. Mayor Meyera E. Oberndorf was the principal speaker. President Kreg Kenney's concluding remarks directed honors to all who serve in a voluntary capacity. He thanked all for being present.

LETTER CARRIER FOOD DRIVE


May 12, 2001, The Saturday before Mother's Day
